


GOLD DISCOVERY DAYS PARADE

Participation in the GDD Parade is subject to the following stipulations:

- Participants shall not spray liquids at the crowd.
- Drugs and alcohol shall not be consumed by any participant on the parade route.
- Each parade participating group must be responsible not only for their safety but must also take precautions to ensure the safety of their float and it's participants.
- Vehicle drivers are solely responsible for the safe operation of their vehicle and each driver must be the holder of a valid driver's license and must have valid auto liability coverage in force. **Copies of each must be presented to parade organizer upon arrival at lineup.**
- Participants with horses or animals of any kind shall provide personnel to perform immediate excrement removal.

Indemnification:

Participant expressly assumes all risks incident to or in connection with participation in the event. Participant agrees to and shall indemnify, defend and hold the Chamber harmless from and against all losses, liabilities, damages, costs, expenses, judgments or settlements whatsoever incurred by the Chamber resulting from any claim, demand, action, cause of action or suit arising from or relating to the negligent or intentional acts or omissions of participant, or its volunteers, employees and others acting on behalf of, or for the benefit of, participant.
